## 2. SPOUT RUN PARKWAY SANITARY SEWER RELINING



### **Project Highlights:**

- This project will rehabilitate a 3,374 linear foot section of 33-inch sewer main which was installed in 1937 and runs under the North Highlands neighborhood; at points this main is over 100 feet deep making maintenance and repairs extremely difficult.
- The main was inspected and cleaned in 2019. Based on condition and accessibility issues, in 2021 the County hired a consultant to review and assess the inspection reports and recommend the approach and method for rehabilitating the sanitary sewer.
- Construction of the sanitary sewer rehabilitation is anticipated to start in spring 2023.
