To receive approval the Establishment must acknowledge that it will comply with each condition listed below by placing a check mark (✓) next to it. During your application review with Environmental Health Program staff, you may be asked to provide details on measures the Establishment will implement to ensure compliance with the conditions.

- ""1. Cooking only; food items shall not be served from the outdoor cooking device.
- ""2. All food transported to the outdoor cooking device must be in clean, covered containers or wrapped and immediately placed on the cooking device.
- ""3. All cooked foods must be immediately transported back to the licensed food establishment in a separate, clean, covered container to prevent cross contamination.
- ""4. The cooking surface must be covered during the cooking process except when it is necessary to turn or stir the food product. ""
- ""5. A method of hand washing shall be provided in the cooking area. A plumbed sink with liquid hand soap and paper towels; or a clean, closed container with potable water and a non-spring loaded spigot, a container to catch the waste water, with liquid hand soap and paper towels provided.
- ""6. Any preparation of foods after it has been cooked such as, but not limited to, placing lettuce or tomatoes on sandwiches shall not be permitted outdoors. ""
- ""7. A solid, smooth surface shall be provided in the cooking area such as concrete, asphalt, sealed wood, etc. ""
- ""8. Cooking operations shall not create a nuisance or hazard or attract insects, rodents, or other vermin.

If approval is granted, the Establishment will comply with the conditions required by the Arlington County Public Health Division as well as the requirements set forth in the FDA Food Code, the Virginia Administrative Code, and Chapter 9.2 of the Arlington County Code. The Establishment understands that the approval may be revoked by the Arlington County Public Health Division if there is violation of the conditions of this application. I represent by my signature below that I am a duly authorized agent of the Establishment and am able to bind it to the obligations stated in this Application.
