SUBJECT: Climate Change, Energy and Environment Commission 2025 Annual Report

The Climate Change, Energy and Environment Commission (C2E2) appreciates the opportunity to present a review of its 2025 activities and actions. In addition to recognizing our own members for contributing their time and expertise on a volunteer basis, we would like to thank Susan Cunningham, who served as Board liaison to C2E2 this year and has been extremely helpful and insightful.

I. Major Accomplishments

- <u>Climate Action Resolution</u> We were delighted to contribute to and celebrate with the Board the passage of the Climate Action Resolution, something C2E2 has been seeking for several years.
- Green Building Incentive Policy- C2E2 worked closely with staff on the revised update to the Green Building Incentive Policy (GBIP). We appreciated the open communication with staff and particularly the opportunity to participate in the August stakeholder roundtable with developers. We look forward to an update of the County's standard site conditions in 2026 as an important part of making the GBIP successful.
- Revised SPRC Scorecard C2E2 substantially updated the scorecard we use to analyze new construction projects in order to reflect innovations in building construction, energy, technology, and marketplace expectations, so that we can provide more constructive advice and help the Board achieve the carbon neutrality goals it has adopted.
- <u>Sustainable Development</u> Through our consistent participation in the site plan review committee (SPRC) process for private sector projects, C2E2 highlighted for the Planning Commission and County Board the strengths and weaknesses of building designs in meeting the County carbon neutrality and other sustainability goals. We were generally supportive, with recommendations for improvement, of nine projects and opposed to one, One Rosslyn. This year we added analyses of adaptive reuse projects to our portfolio despite the lack of required information or public meetings due to the expedited process for these strategic projects.
- Whole-of-Government/Whole-of-Community C2E2 was pleased to see the progress

made on our top priority objective in our work plan, the "whole-of-government and whole-of-community" approach. We applaud the leadership shown by Jennifer Fioretti and the Climate Policy Office in these areas.

- <u>Innovation</u> We sought innovative ideas from external sources and worked to educate ourselves and County staff, with particular kudos to the Energy Committee for bringing in numerous speakers. Together, we heard from the following outside speakers:
 - JBG Smith on sustainability challenges in Arlington Kim Pexton, senior vice president of sustainability
 - Sacramento Municipal Utility District on virtual power plants
 - o Dominion Energy on its virtual power plant pilot program
 - o Voltus, a leader in virtual power plants, on Virginia's virtual power plant
 - o Amazon on its clean energy policy
 - Rappahannock Electric Cooperative on data centers
 - o Ivy Main, well-known energy consultant, on Virginia legislative priorities
 - Securing America's Future Energy on the anticipated impact of artificial intelligence on transportation
 - o Coalition for Green Capital of ICLEI on financing green projects
 - Dandelion Energy on technological advances in geothermal heating in residential homes
 - Rewiring America (former employee) on home electrification David Friedman, now a member of C2E2

These presentations and dialogue with the speakers influenced our work and our advice to the Board.

- Advocacy Group Dialogue C2E2 leadership continued to meet regularly with
 representatives of environmental advocacy groups that are active locally to stay apprised
 of their priorities and insights. While the role of these groups is somewhat different from
 C2E2's role as an advisory commission to the Board, this connectivity and collaboration
 is valuable in informing the advice we give to the Board and continuing to expose C2E2
 to new ideas and perspectives.
- Close Staff Working Relationships Following the much-anticipated creation of the Climate Policy Office (CPO) and hiring of Jennifer Fioretti and Rich Dooley as Assistant County Manager and Director of Climate Policy respectively, C2E2 developed strong relationships with both, inviting them to speak at C2E2 and its Energy Committee regularly and providing feedback on the first CPO work plan and other initiatives. The same is true of Jason Papacosma, who assumed the Bureau Chief of OSEM role, which includes the AIRE team, at the end of 2024. In fact, we have had all six members of the AIRE team present to C2E2 so we understand staff expertise, areas of focus, and capacity. We have found this staff interaction very valuable and hope they feel the same.
