The Community Oversight Board (COB) was called to order by COB Chair Evans at 6:33 p.m. Attendance was taken by voice. Chair Evans introduced Commissioner Shocken as the newest member; Commissioner Shocken introduced herself to the group and to the public.

At 6:34 p.m., Chair Evans began the meeting with updates, including the change in frequency of COB meeting from monthly to bi-weekly.

## **Meeting Minutes**

### **Investigations Review**

At 6:43 p.m. Chair Evans began the Investigation Review Hearing for case 23CMP-018. The case discussion was led by Chair Evans, followed by additional comments from IPA Ibrahim and Captain Kim. During the discussion, Commissioner Ortiz asked for clarification on ACPD policy on dealing with large groups of individuals. At 8:19 p.m., the Community Oversight Board began to finalize their review of this case. The COB leads recommended Exonerated all officers on all allegations except for Not Sustained for Officer 1, 2, 4, 5, and the Supervising Officer on Duty

Commissioner Smith moved to exonerate all officers on all allegations with the exception of Not Sustained for Officer 1, 2, 4, 5, and the Supervising Officer for Duty and Responsibilities, Commissioner Ortiz second, and the motion was unanimously adopted by the Community Oversight Board.
