Welcome and Attendance

The Community Oversight Board (COB) was called to order by COB Chair Evans at 6:30 p.m. Attendance was taken by voice.

Approval of Previous Meeting Minutes

At 6:31 p.m., COB Chair Julie Evans moved to approve previous meeting minutes. The measure passed by with no abstentions or nays.



COB Investigation Review

At 6: 31 p.m. Dave Smith and Anika Montgomery provided an overview of case 25CMP-022. Dave Smith and Anika Montgomery recommended that ACPD reiterate the policies related to this case to the department. At 6:41 p.m. Dave Smith explained that they included ACPD policy 574.02 in their presentation, despite OPR not investigating it, due to its relevance to the case. COB did not vote on that policy violation since it was not reviewed by OPR. The COB leads recommended the following:
