## What is an Invasive Species?

"An invasive species is a species that is not native to a specific region and that tends to spread to a degree believed to cause damage to the environment, human economy or human health."

-Arlington County Forestry and Natural Resources Plan 2024



# Arlington County's Invasive Management

- The County has engaged in invasives control since 2002. Today, over 60% of our 543 acres of Countyowned natural land is in management.
- The Natural Resources Unit follows an Invasive Plant Management Strategy
  - Save the Best First
  - Mechanical, Chemical and Biological controls
  - Public Engagement and Volunteer Support
  - Early Detection, Rapid Response (EDRR)
  - \$100,000 annual budget
- Other invasive work on county land occurs through PDD projects, DES projects, and ANP grants.

Staff from APS and NR have met several times, and clarified how volunteers can best work with APS


APS is drafting a letter of support that stewardship volunteers can share with Principals, PTA landscaping committees, etc.



### **Expanding Local and Regional Collaboration**

The 2023 Forestry and Natural Resources Plan explicitly calls for increased collaboration between DPR and APS

- 3.2.2 Participate in partnerships for invasive species management.
- 1.1.7 Expand and formalize the relationship between APS and DPR to ensure school sites meet community objectives for tree canopy and natural spaces.



#### Prioritize APS Sites with Shared Natural Lands

- At all adjoining sites, DPR is funding invasive management and has an ARMN Park Steward leading volunteer work
- •APS recently added a vendor who can do invasive management
- •APS is planning to fund some invasive management at Jamestown and part of Claremont this year
- •APS expects to fund follow up work next year, as resources allow
