- Stall Occupancy
 - In the ground, battery operated, low power and have a 10 year battery life
- Wireless Gateways
 - Cellular connection to server
 - Mounted to traffic signal poles and other existing infrastructure
- Pilot Approach
 - 3 year project
 - Gather data:
 - Collect occupancy data
 - Conduct pilot outreach
 - Conduct Analysis
 - Review occupancy data
 - Review meter payment compliance data
 - Apply project priorities to pricing model
- Second Phase: Outreach & Engagement
 - Online feedback form
 - Door to door outreach in advance of construction activities in parking spaces

- The Commission discussed the letter drafted by Andrea Wingo, with input from Frank Jazzo and John Burke. The letter reflected the April meeting's cybersecurity briefing and urged following the NIST risk management framework.
- A motion to approve the letter and send it to the County Board was adopted.

Collaboration with Arlington Economic Development Commission (AEDC)

John Burke and Laura Gross briefed AEDC at its May meeting. They gave a brief overview of the Virginia legislative mandate that counties address broadband in their comprehensive plans. There were good questions, but John and Laura did not receive a formal response from AEDC about a specific area of collaboration. Workforce development seemed to be an area in which there was common interest. Frank Jazzo mentioned that he advised ITAC Board liaison Libby Garvey of our outreach to AEDC and she was approving.

Broadband Resource Evaluation and Needs Assessment Report

Frank Jazzo had previously circulated the links to the County's Broadband Resource Evaluation and Needs Assessment Report and slide deck. He reported that he had asked Richard Archambault to invite Jennifer Skow and Holly Hartell, who were the County staff involved in the Broadband report, to brief the Commission on the report, hopefully at the June ITAC meeting. Frank reported that the Broadband report has a webpage on the County's website.

Legislative Update

Frank Jazzo reported that Anna Gomez, currently at the State Department working on International telecom issues, has been nominated to serve on the Federal Communications Commission (FCC). Current FCC Commissioners, Brendan Carr and Geoffrey Starks, were also nominated for new terms.

Work is underway to explore use cases for future 6G wireless networks, with spectrum sharing in the 7-20 GHz bands likely.

The White House national cybersecurity strategy implementation plan should be released this summer.

The FCC ordered voice service providers to block traffic from an international gateway provider found to be facilitating illegal robocall campaigns.

Colorado passed a law to make it easier for local governments to provide broadband service.
