- Beth Kiser spoke about natural capital. It was very informative. Her presentation is recorded.
- Dave Howell spoke about expanding the Community Energy Plan to encompass a more traditional Climate Action Plan, so that all the Comp Plan elements and their interactions are considered in evaluating decisions. A copy of his paper is attached to the PRC agenda. It was agreed that all the Commissions should review his paper and be ready to provide feedback on what they consider the most relevant and important elements. There was overlap with Beth's talk in that the environmental accounts she spoke of could be used to make climate-based assessments.

- Langston Blvd Plan letters are due. UFC and C2E2 put theirs together and sent it in.
- C2E2 rejected one of the developer projects saying that it received the lowest score of any project assessed using their rubric.

 - The Vision Zero external stakeholders group held its year 3 mid-year progress meeting on Thursday, October 19.
 - Progress has been made in reducing severe accidents across the county, but a majority of these types of accidents are still concentrated in the high-injury network. More work is being done to consider crosswalks, intersections and outlining changes to these structures in these areas. Various liaisons to the ESG included input on projects and areas they would like to see updated and improved. There are more changes and projects planned in these higher incident areas.
 - Stakeholder engagement will continue through the future. Those interested can access the comprehensive mid-year report directly from the vision zero group.
