    - Current usage of land: This site is currently undeveloped and consists of a temporary park area with two volleyball courts and a gravel parking lot. Block W is surrounded by mixed-use office and residential buildings. CSX railway tracks are located towards the east, and Crystal Drive is located on the west. An airport off-ramp and a service road run through the site.
    - Proposed usage of land: 383,000 square foot building with 370 residential units, parking (200 spaces), and retail space (3,360 square feet). There is approximately 35,000-38,000 square feet of open space, and designs indicate that the volleyball courts will be kept. Current design is slightly below this 35,000 open space minimum.
      - There is a small amount of space (close to the CSX tracks) that has not been allocated to a specific function yet. Forestry and Natural Resources Commission has proposed planting trees in that space. PRC can support this proposal.
      - Retail and fitness areas overlook the open space which encourages more engagement from the residents/shoppers.
      - Important design elements mentioned: Bird friendly glass is required, pets will have a designated area by the fitness center, the designers plan on having a green roof, and they are working on expanding sidewalks to be ADA approved.
      - Affordable housing concerns: These units will be more affordable than other JBG Smith buildings in the area, which are all high rises. Block W units will be 2-3 bedroom which could mean lower rent.
      - The next meeting will cover more information about design elements for the open space.
