  - Notes from the December FNRC meeting:
    - We first heard public comment on the removal of a zelkova tree from Lyon Park and the objection that several Lyon Park residents had regarding its removal. This tree had been identified by Urban Forestry staff as structurally unsound during their circuit tree maintenance program that started in fall 2024. Neighborhood objections had also been raised with the County Board. The commission discussed the matter at the end of the meeting and heard from the two members of the Urban Forestry Dept on their evaluation and outreach to the community.
    - We then received an extensive update on the Implementation of the Forestry and Natural Resources Plan from Ryan Delaney.
    - Alan Rowsome of the Northern Virginia Conservation Trust joined us as well and delivered a presentation on NVCT's activities, with special emphasis on its work in Arlington County.
