I. Call to Order, David Litman. At 1:00 p.m. SAC Chair, David Litman called the meeting to order. II. FY 2025 Budget, Department of Parks and Recreation Director Jane Randolph. 55+ Registration Day and Time Change

Starting in May, 55+ Programs will be moving the registration dates from Wednesday for Residents up one day to Tuesdays. Out-of-County registration will remain on Thursdays. The reason for the change is due to the Vermont Systems production schedule. Usually, their updates are pushed out on Wednesdays and DPR is trying to avoid having registrations during that time as the updates can slow down the registration process. The registration time is also moving to 12pm. This will not only be consistent with the time DPR holds all other registrations but also addresses the issue of 10am being a popular class time at all the centers. Spring registration was successful for the sports and fitness classes. This spring we brought back pickleball instruction classes after being without an instructor for almost a year. There are 4 classes split between Lubber Run and Arlington Mill. These classes all filled and had a waitlist. Another new class this spring is Zumba Gold. This class is meeting on Tuesday evenings at Arlington Mill.

The 55+ Fitness Day and Health Fair will be held on 5/29/2024 from 10am-noon at Lubber Run. This event is partnering with Virginia Hospital Center and Marymount University. There will be vision and hearing screenings; fall risk assessments; fitness class demonstrations; Q&As with dietitians, pharmacists, and insurance counselors; and more! There event is free and open to all- no 55+ Pass required.

E. Travel Committee, Jim Mason.

At its most recent meeting, on February 13, 2024, the Travel Advisory Committee discussed the comments at the February 2nd “Combined Committees” meeting concerning the need for printed copies of the 55+ Guide, and the possibility of providing a subscription option for seniors wishing to receive their own personal copies in the mail. The members of the Travel Advisory Committee were very supportive of the idea.

The 55+ Travel Program continues to offer a number of diverse and interesting trips for the Arlington senior community. From January through May of this year, travelers have had a choice of over 50 travel options. For our trips in the Spring Catalog that runs March to May, almost all of the trips are full or nearly full. The most popular of these trips include; a Princeton, NJ walking Tour; all three Kennedy Center “Coffee Concerts”; a performance of “The Book of Mormon” at the National Theatre”; Cherry Blossom Tidal Basin Walk; tour of the Franciscan Monastery of the Holy Land in America; Historic Garden Week in Winchester, VA; and a performance of “The Lehman Trilogy” at Shakespeare Theatre.

Stay tuned for the Arlington 55+ Summer Catalog, where we will have a number of other interesting trips. Highlights include: historic Harper’s Ferry, WV; the Chrysler Museum in Norfolk VA; a Chesapeake Bay cruise to St. Michael’s, MD; “Bluegrass in the Burg Festival” in Fredericksburg,

VA; an exhibit on Julia Child at the Virginia Museum of History and Culture in Richmond; and of course, some Washington Nationals baseball games – hope will always spring eternal!
