#### CRIME PREVENTION AND CONTROL

On December 21, while conducting routine patrol an Officer identified a wanted person for failure to pay child support by Arlington County Sheriff's Office. The subject was taken into custody without incident.

On December 26, police responded to the Macedonia Apartments for a bag in the garage. Upon police arrival and investigation, it was determined a bag containing suspected cocaine was in the bag. The identification of the suspected owner was also located. The investigation is ongoing. (2023-12260084)

### December 2 – Shots Fired

At approximately 3:25 p.m., police were dispatched to S. Kenmore Street and 23rd Street S. for multiple reports of shots fired. Responding officers canvassed the area and located evidence confirming several shots had been fired. The preliminary investigation indicates approximately six male suspects were walking in the area when they approached a vehicle exiting the parking lot. The vehicle stopped briefly during which at least one suspect discharged a firearm at the vehicle before it fled the scene at a high rate of speed. The suspects ran from the area immediately following the incident and were not located. (2023-12020176)

## December 9 - Shooting

At approximately 1:03 p.m., police were dispatched to the report of a shooting at S. Kemper Road and S. Oxford Street. The preliminary investigation indicates the female victim was a passenger in a vehicle traveling on S. Oxford Street when four suspects approached on foot and discharged firearms, striking the victim and the vehicle. Following the shooting, the driver of the victim vehicle continued to the 4000-block of S. Four Mile Run Drive where officers located them and began rendering aid to the victim. The victim suffered non-life-threatening injuries and was transported to an area hospital for treatment. (2023-12090129)

### **SEARCH WARRANT AND ARREST**

On December 20, ACPDs
Homicide/Robbery Unit announced two
arrests in the shots fired incident. Elijah
Broadus, 21, of Arlington, Va. was taken
into custody and charged with Shooting
at an Occupied Vehicle, Discharge of a
Firearm within 1,000 feet of a School,
Possession of a Firearm by a Convicted
Felon and Wearing a Mask to Conceal
Identity. Isaiah Grady, 18, of Arlington, Va.
was taken into custody and charged with
Shooting at an Occupied Vehicle and
Discharge of a Firearm within 1,000 feet of
a School.

#### SEARCH WARRANT AND ARREST

On December 14, ACPDs
Homicide/Robbery Unit with the
assistance of the Emergency Response
Team executed a search warrant and
announced Darnell Moore Jr., 18, of
Arlington, VA was taken into custody
and charged with Malicious Wounding,
Shooting with the Intent to Injure, Maim
or Kill: Conspiracy and Use of a Firearm
During the Commission of a Felony.
