Implementation Framework

This is a companion document to Arlington's Comprehensive Plan: Historic and Cultural Resources Plan (the Plan). It describes the implementation approach for the goals and objectives of the Plan and includes a concise summary of the goals and matrixes that illustrate the timeline, cost, funding source, and responsible parties for implementing each objective or action. This is a working document: it should be considered flexible and be reviewed and adjusted as needed. The Historic Preservation Program (HPP) staff have responsibility for this document and will revise it when required.

Focus Areas

The Plan includes five distinct focus area categories: Community Engagement; Incentives for Preservation; Partnerships; Regulations; and Technology, Information, and Tools. Within these, the County seeks to expand existing priorities and establish new initiatives that will ensure a robust and equitable historic preservation program. Each goal also provides an Equity Aspiration, which describes how the goal will advance a more equitable historic preservation outcome for Arlingtonians. As the plan is implemented, it will be important to determine how and when to measure these outcomes. **Community Engagement** refers to education and outreach activities. The proposed activities highlight various preservation initiatives and programs that aim to connect residents who have not traditionally participated in historic preservation with the program. Activities include an annual report and regular newsletter.

Incentives for Preservation are inducements to preserve historic resources. The objectives and actions outlined in this goal include honoring successful preservation efforts, providing financial motivations for preservation, and easing bureaucratic burdens for those willing to undertake historic preservation actions.

Partnerships describe the ways historic preservation can integrate with other County functions. With an overall focus on proactive and informed preservation policy, the objectives in this goal include incorporating historic preservation representatives and considerations into the various planning efforts of the County; the County agencies' capital budgets, inventories, and maintenance plans; the affordable housing and sustainability efforts; and the other County units with cultural elements, such as the Department of Parks and Recreation (DPR) and the Public Art Program.

Regulations focus on optimizing the Local Historic District designation process,

establishing flexible preservation tools, and elevating the protection of high-risk resources, including archaeological resources.

Technology, Information, and Tools help organize and share the foundational data that provide the basis for decision-making in preservation policy and regulation. Actions in this goal encompass updates to and expansion of the Historic Resources Inventory (HRI), historic resource surveys and studies, and establishing an archival program in the HPP.

Resources

The County expanded its historic preservation efforts and therefore, its impact, following the adoption of the original Plan in 2006. This Plan, which is the update to the 2006 document, proposes a significant increase to existing efforts. With appropriate resources to support these aspirations, the HPP has an opportunity to expand its reach and to serve Arlington more equitably and robustly in the future. The estimated resources required to achieve the objectives herein encompass funding for various initiatives, including the Historic Preservation Fund, and three new positions in the HPP:

An archaeologist will oversee archaeology needs, including a new ordinance, plan, and review process, for the County and will provide ongoing archaeology expertise. Arlington

Implementation Framework

County, like most local jurisdictions, originally passed its historic preservation ordinance at a time when archaeology was not considered an integral part of the historic preservation effort.

With the passage of time, a growing understanding of the significant cultural record held underground has led to more historic preservation programs adopting archaeology as a formal part of their practice. This is especially important for significant stories, people, and resources from the long past that may not be obvious at first glance but that are evidenced by rich resources below the earth. In Arlington, these include the stories of Native Americans, agriculture, the Antebellum era, and the Civil War, to name a few. This new position will:

- Develop recommendations for addressing abandoned cemeteries within County boundaries and include the surrounding community in assessing and addressing these properties.
- Generate an Archaeology Ordinance for adoption.
- Create an archaeology plan.
- Establish an archaeology review process for projects on County property.

An archivist will help coordinate records management, accessibility, and research for County information. Arlington County has records and archives pertaining to its administrative and development history, often spread through various departments and without connection or coordination. When information and historical data are needed, there is no centralized organization system or source for accessing it. By organizing and making these records accessible as part of County records management, activities such as research, education, advocacy, and interpretation will be supported and streamlined. This work requires an archivist to manage, digitize, and make records accessible, as well as to oversee retention schedules for today's records. This new position will:

- Develop and staff a program for coordinated records management, accessibility, and research for historical information, both within the HPP archives and across County departments.
- Share Arlington's historic preservation data, information, and physical records within County departments and publicly.

A cultural heritage planner will coordinate cultural heritage elements of historic preservation. Arlington's cultural landscapes are more deeply understood and more visible as a historic preservation priority than ever before and they are increasingly threatened by the overlapping pressures of land use and population needs. This plan recommends increasing public education and building policies around cultural heritage and landscapes under the auspices of the HPP. This new position will accomplish the following:

- Conduct additional architectural and cultural surveys and studies.
- Work with neighborhood advocates to understand, interpret, and support preservation of the physical resources and cultural meaning of their parks and other public spaces.
- Develop recommendations for addressing abandoned cemeteries within County boundaries and include the surrounding community in assessing and addressing these properties.
- Serve as a support to DPR in preserving and interpreting the history and culture of historically significant elements of the County's parks, including the Civil War forts.

The tables below describe the timeline, cost, funding source, and responsible parties for implementing each recommended objective or action.
