

Frequently Asked Questions

When did Arlington County implement Emergency Medical Services (EMS) billing?

The county implemented the program in 1999.

How does billing work?

Arlington County contracts with a company called DigiTech to handle EMS transport billing. After patient care is provided, the billing company attempts to obtain active insurance information through a hospital interface and / or correspondence with patients. Once insurance carriers are billed, they process claims and issue either payments or denials. Patients are billed for any balance not paid by insurance. If uninsured, the patient is billed directly.

I do not have insurance. Will I still be transported?

Yes. No one will ever be denied service based on ability to pay or lack of health insurance. If you do not have insurance coverage, you are responsible for the entire cost of the ambulance transport. However, patients can apply for a Hardship Waiver (form available on our website) to reduce or eliminate their portion of the bill.

I called 911 and an ambulance showed up, but I was not transported. Will I still be charged?

There are scenarios where a patient may be billed for medical services such as treatment in place or telemedicine or treat no transport. In these instances you are provided with treatment at the scene and not transported by ambulance.

What are the charges for emergency medical transport services?

Charges include:

- **BLS (Basic Life Support) Transport - \$750**
- **ALS (Advanced Life Support, Level one) Transport - \$1,000**
- **ALS 2 (Advanced Life Support, Level two) Transport - \$1,000**
- **Mileage - \$15 per mile** (In addition to the above fees, all transports will include this charge)
- **Telemedicine/Treatment-in-place consult - \$200**
- **Treat No Transport (TNT) - \$250**

Will my insurance carrier pay for my ambulance transport?

In most cases, your insurance carrier will pay for a portion of your transport costs. Some insurance carriers will cover the entire expense, but you must check your

insurance benefits. You may receive an invoice from us if we do not have your insurance information, your insurance carrier denies our bill, or if your insurance company only pays a portion of your bill.

How can I obtain a copy of my medical record / ambulance report?

To obtain a copy of your medical record / ambulance report, you must mail a signed Authorization for Release of Protected Information form (form available on our website) which includes the patient's name, date of birth, and incident date along with a payment in the amount of \$5.00 to our office at:
